- Welcome and Introductions
 - Kate Frey New Advocacy Director for New Futures (replaced Tricia Lucas); Will attend all future meetings.
 - Jack Wozmak Director of Substance Use and Behavioral Health for the Governor's Office; Will be attending future meetings as able. Is available to advocate for resources/policies that may be needed to help task force implement goals.
- Review Minutes
 - No edits made to January minutes.
- Current Data Review
 - January and February data provided by the New Hampshire Information & Analysis
 Center were reviewed.
 - From January 1 to February 28 there have been 73 ER heroin use visits. This number is much higher compared to the same months in the past three years.
 - More men have been admitted to the ER for heroin use compared to women.
 - Individuals 26 years of age or older exhibited the highest number of treatment admissions.
 - There were 300 overdose deaths in 2014 with 40 cases pending.
 - More fentanyl related overdoses compared to heroin
- Updates and Information Sharing
 - Legislative
 - HB271 Bill for family and friends having the ability to disseminate and administer narcan with limited liability
 - SB45 Medications will not be paid for among Worker's Compensation recipients after 90 days if an opioid treatment plan is not obtained.
 - HB270 Looks to grant immunity from criminal prosecution to certain persons involved in a drug or alcohol related emergency; relative to protect people who call in an overdose
 - SB67 Establish a committee to study opioid misuse; task will be to create a report with recommendations for the legislature. Discussed redundancy of

- having two groups and possibility of Senator D'Allesandro participating in the Opioid Task Force. **Seddon will reach out and invite to participate.
- SB31 PDMP housekeeping changes to include dissemination of de-identified data available to others and interoperability with other NE states.

Agency & Organization Updates

- New Futures
 - A rally was held at the Statehouse which was attended by over 500 individuals to represent the 300 lives lost due to substance abuse.
 - Working with Senator Jeanie Forrester to determine how to secure SUD budget
 - Will support HB270 Good Samaritan Bill
 - Information session for legislatures on April 14th at Legislative Office Building presented by Doug Marlow (national speaker) related to Drug Courts
- Board of Pharmacy
 - 65% of prescribers have signed up to use the PDMP; those registered tend to also use the system
- Healthcare Workgroup
 - Continuing to work on goals; SBIRT in primary care to expand to ERs, expanding access to buprenorphine with CHCs, naloxone expansion
- Safety & Law Enforcement
 - Similar trends seen; overprescribing of meds
 - Doctor shopping has decreased with less numbers seen this year; may be attributed to PDMP
- Recovery
 - Amy gave an overview of SMART recovery, a four-principle approach to recovery
- o Meetings, events, conferences
 - May 7th Dartmouth Symposium: Improving Systems to Reduce Opioid Related Harm
 - Seddon requested everyone to disseminate conference info with contact lists
 - Currently being planned; brainstormed presenters for various agenda topics
