			Medicaid/Medicare are public programs not self-funded and not insurance. Administered by DHHS, not Department of Insurance (DOI). However, NHHPP (Medicaid expansion) is now covered through the private insurance marketplace and are covered by commercial carriers, called Premium Assistance		
			Program (PAP). DOI regulates the carriers and can intervene		
			on consumer's behalf.

			Urgency of prior authorization is defined by the provider not the carrier. See handouts and Nh.gov\insurance click the file a complaint button DOI currently reviewing SUD benefit administration across carriers in NH. Will also be revising network adequacy rules for 'reasonable access' likely to change significantly in 2018. DOI has created a mental health and substance use workgroup to identify and address issues/barriers. Stephanie, Monica, Jamie and others are participating. When in doubt call DOI, they get virtually no questions, calls, complaints re SUD to consumer services from either clients or providers.

Should be voted and passed Thursday through the Senate.	Clean needles bill deadlocked out of committee, goes to House floor – NF supporting. Suspension (instead of revocation) of Medicaid benefits for incarcerated beneficiaries will now be the standard in NH! Therefore, benefits available for reactivation immediately upon release. SB533 Governor's Commission bill originally for additional funding now could fundamentally change GC. Neglect bill defines addiction and/or neonatal abstinence syndrome as neglect automatically – passed Senate NF to continue to oppose in the House.
