### **Other Updates:**

\*Doreen highlighted that the CoP would invite the Board of Licensing for Alcohol and Other Drug Professionals to discuss CRSW licensure and licensure renewal. Cheryle P asked the group to send any questions that they have relative to CRSW licensure to Rehka so that she can assist the licensing board in preparing their presentation.

Melissa asked if the community needs to work to draft legislation to set standards for CRSW licensure. Courtney explained that CRSW licensure is governed by administrative rules. Cheryl Lawson asked if He-W 513 governed the CRSW licensure. Courtney explained that He-W 300 govern CRSW licensure. Courtney said the rules went to JCAR on September 15th. Dianne told the group that the Board

approved the rules yesterday, October 13th. Therefore, any applications dated prior to October 13th would likely be reviewed using the old requirements.

Cheryl expressed concern about Medicaid reimbursement. Courtney noted that the Providers Association can work with Cheryl and the community to work on amending He-W 513 to address current concerns. However, the Board of Licensing for Alcohol and Other Drug Professionals will be limiting the scope of their presentation to He-W 300, licensure.
